Online orders are limited to full case purchases (12 bottles) or more. Please contact the Vineyard to discuss purchases of 6 bottles.

# Resale

All goods purchased must be for personal use, not for the purposes of resale.

# Wine-Club Specific Conditions

You must be 18 years of age or older, to become a member of the Cannibal Creek Wine Club.

The Cannibal Creek Wine Club requires the purchase of 12 bottles of wine, 2 times per year, for a minimum of 18 months (minimum 3 deliveries). There is an up front charge for the first purchase of \$300, followed by \$300 charged automatically for each subsequent delivery.

You agree to hand select or automatically receive their wine club dozen twice a year.



A 25% discount will apply to any additional current release wine purchases (6 bottles or more) throughout the year (excluding special offers).

Free shipping will be applied on additional full case orders (within Australia only).

If you do not send us your selected dozen by the specified date, Cannibal Creek Vineyard will hand pick a dozen and send this to you, with the wine cost charged to your credit card (\$300).

### **Change of Details**

You will notify Cannibal Creek Vineyard of any changes to your member details. Wine Club deliveries will be charged to members in accordance with details provided to us by you.

### Cancellation

Membership may be cancelled at any time via email or phone after the third\* wine club shipment has been delivered, otherwise the equivalent cost of remaining deliveries within the minimum initial 18month sign up period will be charged as cancellation fee. \*Special offers / other purchases excluded.
